Sheila has also taught advocacy for the National Institute for Trial Advocacy in Canada, the United States, England, Scotland, New Zealand and El Salvador, as well as for the U.N. War Crimes Tribunal in Rwanda and the Special Court in Sierra Leone. She has also conducted advocacy programs for the Foundation for International Arbitration Advocacy in Switzerland, France, England, Brazil, India and Singapore. She has participated in advocacy demonstrations at conferences, including the Cambridge lectures in Cambridge, England; the Canadian Bar Association Annual Meeting in London, England; the Advocacy Symposium in Toronto, Ontario; and the Institute for Continuing Legal Education in Ann Arbor, Michigan. She has taught an intensive advocacy course at the University of Toronto Law School and has taught in the LLM program in litigation offered by the Osgoode Hall Law School.

Sheila is a Trustee and the Former President for the Harold G. Fox Foundation, the Chair for the Touching Tiny Lives Foundation and a Trustee for the Foundation for International Arbitration Advocacy in Geneva. She is also on the President's Council for the University of Ottawa, and the Advisory Board for the Program on Ethics, Business and the Law at University of Toronto Law School. As well, she was the former director for the Canadian Civil Liberties Association.
